- 6. The Citizen's Charter was first published on July 10, 2009 and the latest review and revision made was on March 10, 2016 as required under Section 4, Rule IV of the IRR: The officer or agency shall review the Citizen's Charter whenever necessary, but not less than once every two years
- 7. The Citizen's Charter already shows the improvements that resulted from the process review of frontline service delivery.
